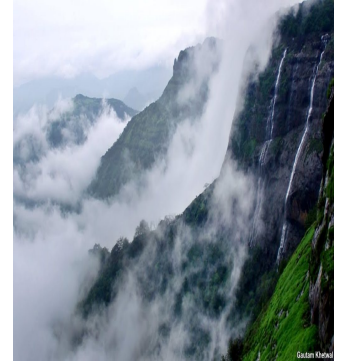

Upon completion of the signed booking form a deposit of 50% of the tour cost per person, be paid to the company.

### **Payments :**

For the services contracted, 50% advance payment should be made to hold the booking on a confirmed basis and the balance amount can be paid at least 7 days prior to your date of departure . We hold the right to decide upon the amount to be paid as an advance payment, based on the nature of services and the time left for the commencement of the services. A part from the above in some cases like special train journeys, hotel or resort bookings during the peak season (X-Mas, New Year) full payment is required to be sent in advance.

Early arrival is subject to availability. For guaranteed early check-in, reservation needs to be made starting from the previous night.

### **Extra Usage of Vehicle :**

We reserves the right to refuse to carry out its contract with any person whom it may consider to be undesirable in its absolute discretion and it shall not be required to show any reason for doing so. All disputes arising in connection with this Agreement shall be referred to an Arbitrator to be appointed by us. All such disputes shall be subject to the jurisdiction of Pune (India) Courts only. The laws of India shall govern the validity, interpretation, construction, performance and enforcement of these terms and conditions.

## **Cancellation Policy**

**Policy Regarding Cancellation / NO SHOW / EARLY DEPARTURE:** In case of cancellation of tour/travel services due to any avoidable/unavoidable reason/s we must be informed in writing.

Cancellation charges would be effective from the date we receive letter in writing and cancellation charges would be as follows:

120 Day & Prior to arrival – 5% of the tour/service cost (Just transaction charges or bank charges).

119 Days to 75 Days Prior to Arrival – 10% of the tour/service cost.

74 Days to 40 Days Prior to Arrival – 20% of the tour/service cost.

39 Days to 20 Days Prior to Arrival – 25% of the tour/service cost.

19 Days to 08 Days Prior to Arrival – 50% of the tour/service cost.

07 Days or Less, Prior to Arrival / No Show – No Refund.

**Please Note :**

1. Irrespective of above mentioned cancellations slabs – In case of cancellation of tour / travel services after the booking is made with us – a minimum 10% service charges would be applicable.

2. In case you cancel the trip after commencement refund would be restricted to a limited amount that too would depend on the amount that we would be able to recover from the hoteliers we patronize. For unused hotel accommodation, chartered transportation and missed meals etc. we do not bear any responsibility to refund.

3. In case of special train journey (like Palace on Wheels, Royal Rajasthan on Wheels, Deccan Odyssey, Golden Chariot, Indian Maharaja & Maharajas Express) – a separate cancellation policy is applicable (which would be advised as and when required).

4. Please note that if booking for following period is/are cancelled, due to whatsoever reason, no refund would be made for said cancellation.

i) High Peak Season Bookings (from 20th Dec to 15th Jan).

ii) Festival Period Bookings (Festivals like -Diwali, Dusshera, Holi, Pushkar Fair etc.).

iii) Long Weekends Bookings.
