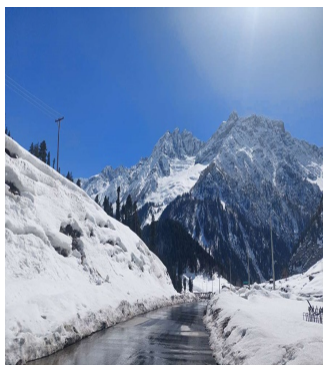

06D Kashmir Heaven on Earth - 5 Nights / 6 Days

Cities Covered: >> Srinagar >> Pahalgam



Kashmir - Known as the heaven on earth. Famous for its picturesque view is a paradise in summers and beautifully decorated white with snow in winters. Come and enjoy a shikara ride at Dal lake, admire the beauty of Pahalgam, gulmarg and Sonmarg along with outdoor activities and lot more..

Day 1: Srinagar:

On arrival at Srinagar Airport. Meet our representative and get transfer to your hotel. Srinagar is the largest city and the capital of Kashmir. Sri nagar is situated in Kashmir valley, on the banks of the Jhelum River, a tributary of the Indus, and also Dal and Anchar lakes. The city is known for its natural environment, gardens, waterfronts and houseboats. Check in to the hotel. Later, proceed for local sightseeing and shikara ride at Dal Lake. Local sightseeing covering the famous Mughal Gardens Nishat Bagh "Abode of Pleasure on the shore of the Dal Lake", Shalimar Bagh "Abode of Love built by Jahangir for his wife Empress Noor Jehan", Chashma Shahi & Pari Mahal. Overnight stay at the hotel in Srinagar..

Day 2: Srinagar:

After breakfast we will drive to the majestic mountains of Sonmarg.(The meadow of Gold) The route towards Sonmarg takes us on a picturesque country side drive where we will come across rolling hills, green forests, clear water streams and blooming rice fields. We will zoom past the

town of Kangan which handles all the local needs of this region. From Kangan, we will drive towards Mammarg, famous for its trout farm and stopover for a warm cup of tea before we head towards Sonmarg. We will once again alight from our vehicles at the tourist spot of Gagangir. Enjoy all sightseeing and activities, later back to Srinagar. Dinner at hotel. Stay overnight at hotel.

Day 3: Srinagar:

After early breakfast at hotel drive from Gulmarg (8700 ft i.e. 2652 mts), narrated beautifully by the Kashmiri romantic poet in the 16th century who was inspired with its grassy slopes covered with wild flowers. In winter Gulmarg looks more beautiful due to heavy snow fall. And turns into India's premier Ski resort in winter. The Gondola Cable Car (optional) offers rides to the upland meadows of Kongdori and beyond to the top of Apharwat range to a height of 14000 ft for viewing the Himalayan Peaks in summer and for downhill skiing in winter. One can have Gondola ride (cable car directly payable) from Gulmarg to Khalinmarg. Overnight in hotel in Srinagar.

Day 4: Srinagar:

After breakfast, check out from the hotel and drive to Pahalgam, Pahalgam in the south east of Srinagar situated at an altitude of (2130.mtrs.) above sea level. It is Kashmir's most popular resort surrounded by high mountains, dense forests, high mountain lakes. Evening at leisure. Overnight at Pah

Day 5: Pahalgam:

Today after breakfast, proceed for sightseeing, Betaab Valley, Aru Valley & Chandanwari (at your own cost – only cars operated by locals are allowed). Witness the striking beauty of mountains. Enjoy walking around Aru Village. A walk along the Lidder stream towards Pahalgam from Aru Village is very highly recommended for Nature Lovers. Later drive back to Srinagar. Overnight in Srinagar.

Day 6: Pahalgam:

After breakfast check-out from the hotel and proceed to Srinagar Airport to get the flight for onward destination.

Cancellation Policy -

Travelers/Guests/Customers OR booking Agents must notify Go Beyond Tours in writing on mail@gobeyondtours.in for any cancellation. We will NOT provide partial or full refunds for missed or unused services. Our cancellation policies and related fees are mentioned as a percent of the total booking price based on the booking's start date i.e. first day of service.

The following cancellation policy is applicable and applicable fees is mentioned as a percentage of total booking price for Standard Tours booked directly on our website -

- 100% refund of the total booking price IF the cancellation request is received more than 30 days prior to the travel date / first day of service.

- 50% refund of the total booking price IF the cancellation request is received between 15 and 29 days prior to the travel date i.e. first day of service.
- No refund of the total booking amount IF the cancellation is received less than 15 days prior to the travel date / first day of service.
